Section 708A Notice and Appendix 2A

This notice is given by engage:BDR Limited (**Company**) under Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

In accordance with the terms and conditions of the Convertible Securities Purchase Agreement (**Agreement**) between the Company and Alto Opportunity Master Fund SPC – Segregated Master Portfolio B (**Alto**), the Company is required to issue replenishment Collateral Shares to Alto. 62,646,249 replenishment Collateral Shares will be issued in accordance with the Agreement.

The Company also today issued 61,939,034 fully paid ordinary shares for settlement of creditor balances.

The Company hereby confirms that:

- (a) On 28 July 2020 it has issued 62,646,249 fully paid ordinary shares to Alto at a deemed issue price of \$0.004 (0.4 cents) per share;
- (b) On 28 July 2020 it has issued 61,939,034 fully paid ordinary shares for settlement of creditor balances at a deemed issue price of \$0.009 (0.9 cents) per Share.
- (c) the shares referred to in paragraphs (a) and (b) above were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (d) the Company is providing this notice under paragraph 5(e) of Section 708A of the Corporations Act;
- (e) as at the date of this notice the Company, as a disclosing entity under the Corporations Act, has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) Section 674 of the Corporations Act as it applies to the Company; and
- (f) as at the date of this announcement, there is no excluded information of the type referred to in Sections 708A(7) and 708A(8) of the Corporations Act.
