Summary of the Newcrest Sign-on Plan

The Newcrest Sign-on Plan provides an eligible new employee of the Newcrest Group with an opportunity to receive a grant of sign-on performance rights (**Rights**) to acquire fully paid ordinary shares in Newcrest (**shares**).

The Rights are granted free of charge and each comprises a right to acquire one share.

The Rights will have a Performance Measurement Date and may be divided into tranches with different Performance Measurement Dates.

Vesting of Rights is subject to the employee remaining employed by the Newcrest Group and satisfying any applicable performance conditions. Vesting of Rights will be determined by the Board of Newcrest but will be as soon as practicable after the relevant Performance Measurement Date.

The Board may exercise its discretion to allow all or some unvested Rights to vest if a change of control event occurs.

The clawback treatment set out on page 77 of the 2019 Annual Report (https://www.newcrest.com/sites/default/files/2019-10/191004_Newcrest%20Annual%20Report_0.pdf) applies to the Rights.
