IBX Secures Additional Capital - Shareholders Exercise Options

MELBOURNE — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announce that it has received \$1.29m for the exercise of unlisted options issued under the terms of the 2018 Rights Issue outlined in the information booklet dated 24 September 2018. The options were exercisable at 6 cents on or before 27 November 2020.

Combining these funds with the funds received from the oversubscribed placement announced on 29 July 2020, the Company has improved its unaudited cash position to \$10.2 million, on a pro forma basis based on the cash position reported 30 June 2020.

In addition, the Company has received requests for the exercise of 33,200 of the listed options expiring 23 April 2023.

The exercise of these options has resulted in the issue of 21,633,200 fully paid ordinary shares, as outlined in the attached application for quotation (Appendix 2A).
