### **Share Issue**

Engage:BDR Limited (ASX: EN1) (**EN1** or the Company) advises in accordance with the terms and conditions of the Convertible Securities Purchase Agreement (**Agreement**) between the Company and Alto Opportunity Master Fund SPC – Segregated Master Portfolio B (**Alto**), the Company is required to issue replenishment Collateral Shares to Alto. 80,318,305 replenishment Collateral Shares will be issued in accordance with the Agreement.

Alto has requested a replenishment of collateral shares, in the interim while the Company and Alto negotiate a cash retirement of the note balances. The collateral shares will be offset against the August amortization payment due to Alto as per the ZCS agreement. In July 2020, the Company had made the election to satisfy the August amortization payment in shares. Beginning with the September amortization payment, the Company intends to make all future amortization payments in cash and has sent Alto a notice for election in cash for future amortization payments.
