#### FY2020 FINANCIAL RESULTS UPDATE - NON-CASH GOODWILL IMPAIRMENT

As part of Australian Dairy Nutritionals Limited's (AHF or the Group) audit of its financial results for the year ended 30 June 2020 AHF provides this update regarding a non-cash impairment of the value of the goodwill associated with its acquisition of Camperdown Dairy Company (**CDC**) in April 2016.

AHF has concluded an intangible asset testing process required by the Australian Accounting Standards on CDC and advises that the carrying value of the goodwill on acquisition of CDC will be impaired by \$4.26 million to \$2.35 million.

The Board has taken a conservative approach to the underlying calculations including the discount rate and has taken into account the uncertain conditions impacting the Australian economy as a result of COVID-19. The writedown has no impact on the cash position of the business or its future operations and the directors believe there is significant value in the Camperdown plant operations and portfolio of brand names not recorded on the balance sheet.

The Board remains optimistic about the prospects of CDC including positive changes to the range of The Collective yoghurts in Woolworths stores from October 2020, introduction of the Group's new Ecklin South yoghurt in Coles stores nationally and growth in its home delivery distribution channel. Furthermore, the Board is also expecting a positive financial impact of the Group's new nutritionals and infant formula plant expected to be operational in FY22 and beyond.

The Group will lodge its Appendix 4E and Annual Report on Monday 31 August 2020.
