#### **IBX Secures Additional Capital - Shareholders Exercise Options**

**MELBOURNE** — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announce that it has received a total of \$82,939.98 for the exercise of Listed Options.
