BEAM RECEIVES LARGEST ORDER OF ZOLEO TO DATE

Highlights:

- **Beam receives significant order of 7,750 ZOLEO units from JV entity**
- **New order follows expanded reseller agreements with world's largest outdoor gear retailer (BPS) in USA and London Drugs of Canada**
- **Total shipped orders for ZOLEO to hit 22,000 units by December quarter**

Beam Communications Holdings Ltd (ASX: BCC) is pleased to announce that it has received its fourth and, to date, its largest order for 7,750 ZOLEO units from its joint venture (JV) entity ZOLEO Inc.

The new order is to fulfil increased demand for the innovative global messaging device after BPS Direct, LLC, the owner of Bass Pro Shops and Cabela's, expanded its reseller agreement with Beam's JV partner, Roadpost Inc.

ZOLEO was initially sold through Cabela's Canada and BPS will now also stock the device in stores located in the United States.

Beam has so far secured commercial distribution and sales arrangements with 17 ZOLEO resellers, in addition to its online channels including Amazon Australia, eBay Australia and Myer Online. Negotiations are underway to bring other national retail chains on board by year-end.

Major Canadian department chain London Drugs Ltd. has also commenced selling ZOLEO across its 80 stores.
