**Form 605 - Notice of ceasing to be a substantial holder**

I am writing on behalf of Gobleg Pty Ltd and each of the persons listed in the enclosed form (**Gobleg**).

Please find enclosed a Form 605 for Gobleg in respect of its shareholding in Whispir Limited (**Company**).

Gobleg became a substantial holder in the Company upon its admission to the Official List of ASX Limited on 18 June 2019. Due to an administrative oversight, no Form 603 was lodged on behalf of Gobleg at such time. However, Gobleg's shareholding in the Company was otherwise fully disclosed at that time, and has continued to be disclosed in the Company's Annual Reports for 2019 and 2020.

As a result of a block trade after market close on 9 September 2020, Gobleg's shareholding in the Company decreased by more than 1% from its shareholding on 18 June 2019 and to such an extent that Gobleg is no longer a substantial holder in the Company.
