LiveHire Limited (ASX: LVH) ("LiveHire" or the "Company") advises that today it has issued 2,289,041 fully paid ordinary shares in the Company ("Shares"), of which:

- 380,926 Shares were issued as a result of the exercise of 1 million unlisted options pursuant to the cashless exercise facility, using a market price of \$0.3044, being the 5-day VWAP as at close of market on 9 September 2020;
- 408,535 Shares were issued on conversion of that number of unlisted performance rights ("Performance Rights") issued under the Company's employee incentive plan ("EIP") after the satisfaction of the relevant vesting conditions applicable to those Performance Rights; and
- 1,499,580 Shares were issued to Christy Forest, Managing Director of the Company, on conversion of that number of Performance Rights issued outside of the EIP.

The Company attaches an Appendix 2A in relation to the quotation of Shares and an Appendix 3Y in respect of Christy Forest's change in interests as a result of the issue of Shares.

Additionally, the Company advises that it has cancelled 100,000 Performance Rights due to the holder of the Performance Rights ceasing to be an employee of the Company.
