The Company advises that it has issued fully paid ordinary shares in the capital of the Company upon the conversion of Class L Performance Rights and Class C Restricted Stock Units (“**Securities**”), per the attached Appendix 2A.

The Company advises that the Securities were issued without disclosure to investors under Part 6D.2 of the Act. The Company, as at the date of this notice, has complied with:

In the event that any such customer proposals become sufficiently certain or material enough to warrant disclosure to the market, the Company will comply with its disclosure obligations at that time.
