ISSUE OF RIGHTS ISSUE SHARES (APPENDIX 2A) AND SHORTFALL UPDATE

Cipherpoint Limited (ASX:CPT) (Cipherpoint or the Company) is pleased to announce that it has today issued 30,391,797 shares to existing shareholders of the Company who took up their entitlements under, and applied for shortfall from, the non-renounceable pro-rata rights issue offer of 1 new share for every 2 shares (**Rights Issue**).

An Appendix 2A for the issue of these shares is enclosed with this announcement.

As noted in the Company's announcement on 25 September 2020, the Company has entered into an agreement to place the shortfall which it expects to complete in the coming days. Following the issue of the balance of the shortfall shares, the Company will have raised approximately \$2.321 million under the Rights Issue, being the maximum subscription amount under the Rights Issue.

The Board of the Company thanks participants in the Rights Issue for their support.
