Xped Limited (ASX: XPE) ("XPE" or the "Company") refers to the Quarterly Activity Report and Appendix 4C for the quarter ending 30 June 2020 lodged with the ASX on 31 July 2020, which have differences with the Company audited cashflow statement for the year ended 30 June 2020.

The main differences identified are classification of lease liability repayments from the initial adoption of AASB16, incorrect treatment of borrowing repayments and reclassification of term deposits as cash and cash equivalents.
