Completion of Rights Issue

The Board of Powerhouse Ventures Limited (PVL or the Company) is pleased to advise that the final allotment of 2,617,307 shortfall shares (and attaching options) has been completed and \$A130,865.35 has been received as cleared funds.

This final allotment means that the non-renounceable entitlement offer and the shortfall offer that were announced on 17 July 2020 have closed and the full amount of \$A1,615,587 (before costs) has been raised.

Total costs of the offer were A\$104,822, against the budgeted amount \$A129,780 detailed in the Prospectus lodged on 17 July 2020.

For the purposes of clarity, the capital structure of PVL is now:

- 64,623,466 Fully Paid Ordinary Shares (ASX ticker "PVL")
- 40,311,733 Listed Options exercise price of \$A0.07 and expiring on 31 December 2023 (ASX ticker "PVLO")


