SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT

bid (Trading name for BidEnergy Limited ASX: BID) (“BID” or “the Company”) gives this notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (“**Corporations Act**”).

The Company advises that it has issued fully paid ordinary shares in the capital of the Company (“**Securities**”) upon the conversion of Performance Rights and Restricted Stock Units, per the attached Appendix 2A.

The Company advises that the Securities were issued without disclosure to investors under Part 6D.2 of the Act. The Company, as at the date of this notice, has complied with:

- (a) the provisions of Chapter 2M of the Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.

Bid also regularly evaluates opportunities for inorganic growth, and at any time may be evaluating and assessing prospective targets. In the event that any customer or investment / acquisition proposals become sufficiently certain or material enough to warrant disclosure to the market, the Company will comply with its disclosure obligations at that time.
