## **CLEANSING NOTICE**

### **Notice under Section 708A(5)(e) of the *Corporations Act 2001* (Cth)**

This notice is given by OceanaGold Corporation (ARBN 124 980 187) (the "Company") under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the "Australian Corporations Act").

The Company advises that:
