Highlights

- Founding shareholder and former CEO, Mr Nir Gabay Exercises 1,880,000 options
- Option exercise funded through the cross sale of shares to a long-term shareholder

13 November 2020 – Elsight Limited (ASX: ELS) ('Elsight Ltd, 'Elsight' or 'the Company'), an ASX-listed company that develops advanced communication technologies for real-time data, video, and audio transmission over cellular networks in mission-critical environments, announces the exercise of share options by its Founding CEO and largest shareholder, Mr Nir Gabay.

As indicated on 14 August 2020 Mr Gabay has begun the process of exercising share options with the exercise of 1,880,000 options to purchase shares at \$0.2 for a total consideration of \$376,000. This was funded by the sale of 1,400,000 shares to a strategic long-term shareholder. The share sale was conducted in accordance with the company share trading policy.
