Appendix 2A– Application for Quotation of Securities

The XTEK Board has recently completed a review of staff incentive remuneration arrangements for 2020 and as part of this process, has approved the issue of new securities to Eligible Employees of the Company.

The Company advises that in accordance with Section 708 (12) of the Corporations Act, 205,229 new securities have been issued to Eligible Employees, inclusive of issues made to related parties as approved at the 2019 Annual General Meeting.

Pursuant to the application for official quotation of these new securities, XTEK confirms the following:
