Grant of Unlisted Options

Melbourne, **Australia**, **20 November 2020** - Avecho Biotechnology Limited (ASX: AVE) ("Avecho" or the "Company"), a company that develops and commercialises innovative Human and Animal Health products using its proprietary drug delivery system called TPM[®], advises that at its next Annual General Meeting, shareholders will consider the grant of unlisted Options ("Options") to Directors of the Company.

On 20 November 2020, the Company granted 83,866,515 Options to all Executives and staff at an exercise price of \$0.0169 (1.69 cents) per Option, being a 45% premium on a 30-day weighted average price at which the Company's shares have been traded immediately prior to 2 November 2020 (last trading date being 30 October 2020). An Appendix 3G is annexed to this announcement.

The Directors have also been offered 17,971,396 Options at the same exercise price of \$0.0169 (1.69 cents) per Option. These Options will be subject to Shareholder approval being received at the 2021 Annual General Meeting of the Company.
