MMA Offshore Limited ('MRM')

The company has a combination of over 30+ high-quality vessels, strategically located onshore facilities, specialised subsea services and in-house technical marine expertise which enables it to partner with clients to deliver innovative, fit-for-purpose marine solutions.

Cooper Energy Limited ('COE')

COE is an upstream oil and gas exploration and production company, engaging in securing, finding, developing, producing, and selling of hydrocarbons to south-east Australia. It explores and evaluates oil and gas, and produces and sells crude oil in the Cooper Basin. The company also produces offshore gas from the Sole gas field in the Gippsland Basin, Victoria, and offshore gas and gas liquids from gas fields in the Otway Basin, Victoria.

I will also be making some general remarks about the TOP portfolio, including the recently announced transaction announced by AMA Group Limited, a refinancing by Money3 Corporation Limited, and the substantial capital raising by MMA Offshore Limited, as well how we see the outlook for the economy and markets over 2020 and beyond.
