- Placement - 123,529,412 fully ordinary paid shares (**Shares**) in the Company at an issue price of \$0.17 (17.00 cents) per Share from the share placement announced on 25 November 2020; and
- Lead Manager Options – 10,500,000 unlisted options (**Options**) will be issued to the Lead Manager. The Options are exercisable at \$0.30 (30.00 cents) per share and expire on 02 December 2022.

(b) The Shares rank pari passu with existing Nova ordinary shares.

(c) The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.

(d) As at the date of this notice, the Company has complied with:

- the provisions of Chapter 2M of the Corporations Act, as they apply to the Company; and
- Section 674 of the Corporation Act.
