Section 708A Cleansing Notice and Appendix 2A

Auctus Investment Group Limited (ASX: AVC) (**Auctus** or **the Company**) advises that it has issued 2,000,000 fully paid ordinary shares in accordance with the Company's Loan Funded Share Plan and shareholder approval sought at the Company's 2020 Annual General Meeting (AGM). The Loan Funded Shares have been issued with a deemed issue price of \$0.54 (54 cents) per share and will be placed in a holding lock until such time as the loan has been repaid.

Section 708A Cleansing Notice

This notice is given by the Company under Section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act).

The Company hereby confirms that:

- a) It has issued 2,000,000 fully paid ordinary shares (**Shares**) with a deemed issue price of \$0.54 (54 cents) per share in accordance with the Company's Loan Funded Share Plan without disclosure to investors under part 6D.2 Corporations Act;
- b) The Company is providing this notice under section 708A(5)(e) of the Corporations Act;
