Request for Trading Halt

Pursuant to Listing Rule 17.1, Tigers Realm Coal Limited (ASX: TIG) (TIG) requests a trading halt in respect of TIG's ordinary shares from the commencement of trading today, 16 December 2020.

In accordance with Listing Rule 17.1, TIG advises that:

- the trading halt is requested pending an announcement by TIG in relation to a proposed (a) capital raising;
