NOTIFICATION OF CANCELLATION OF SHARES

In accordance with the requirements of the ASX Listing Rule 3.8A, rhipe Limited ("**rhipe**" or "the **Company**") attaches a copy of Form 484 lodged with ASIC today, in relation to the cancellation of 57,263 fully paid ordinary shares bought back under an off-market share buy-back.

As a result, rhipe now has 161,075,376 fully paid shares (**Shares**) on issue, including 160,609,537 quoted shares and 465,839 Unquoted ASX restricted shares. Completion of the buy-back was previously notified to the ASX on Wednesday, 23 December 2020.
