## **Section 708A Notice and Appendix 2A**

Optiscan Imaging Limited (ASX: OIL) (**Optiscan or the Company**) advises that it issued 40,000 fully paid ordinary shares (Shares) following conversion of 40,000 unlisted options.

### **Section 708A Cleansing Notice**
