

# Australian Primary Hemp secures second retail distribution agreement with Woolworths

## **Highlights**

- Australian Primary Hemp secures second retail distribution agreement with Woolworths
- APH's new Mt. Elephant 'mylk' branded hemp and oat milk to be ranged in 165 premium Woolworths stores from April 2021
- APH expects this second retail distribution agreement with Woolworths to generate sales revenue of approximately \$250,000 per annum commencing April 2021
- Mt. Elephant brand continues to achieve commercial success and momentum

Melbourne, Australia; 8 February 2021: Australian Primary Hemp Ltd (ASX: APH) ("APH" or the "Company"), a producer, manufacturer, and distributor of premium plant-based health and wellness products, is pleased to announce it has secured a second retail distribution agreement with Woolworths Group Limited ("Woolworths"). This second distribution agreement ("Agreement") will see APH's Mt. Elephant 'mylk' branded hemp and oat milk carried in more than 165 premium Woolworths stores across Australia from April 2021.

The Mt. Elephant brand continues to achieve commercial success and momentum. This latest agreement follows the first distribution agreement with Woolworths in January 2021 for Mt. Elephant baking products (see ASX announcement dated 18 January 2021) and a retail distribution agreement secured with 7-Eleven Australia Pty Ltd in November 2020 for Mt. Elephant hemp seed-and-nut snack bars (see ASX announcement dated 16 November 2020). APH expects the Agreement to yield sales revenue of approximately \$250,000 per annum commencing April 2021.

The two Mt. Elephant mylk products to be carried by Woolworths are a barista/original oat and hemp mylk and a chocolate oat and hemp mylk. Mylk is an ideal complement to coffee, with hemp lending a nutty flavour and a creamy consistency due to its oat content. APH trialled mylk with a number of Melbourne-based baristas to develop its texture and flavour profile. Mylk also contains highly digestible plant-based protein and a complete essential amino acid profile, whilst being low in saturated fats, free from cholesterol, high in polyunsaturated fats, packed with vitamins and minerals, and is 100% vegan.

The global plant-based milk market is expected to be worth AUD \$28.0 billion by 2026\*, with growth driven by consumers seeking innovative and nutritious alternatives to dairy milk other than soy or almond milk.
