Share Purchase Plan

As announced to ASX on 4 March 2021, Eligible Shareholders have the opportunity to participate in the Share Purchase Plan offer (**SPP**) by applying for up to \$30,000 of fully paid ordinary shares in 4DMedical Limited (**Company**) (**New Shares**) without incurring brokerage or transaction costs.

New Shares issued under the SPP will be issued on 7 April 2021 and will rank equally with existing fully paid ordinary shares in the Company (**4DX Shares**) and carry the same voting rights and other entitlements. The New Shares are expected to commence quotation on ASX on 7 April 2021.

Further details of the SPP are set out in the attached documents.

Invitation to participate in Share Purchase Plan

4DMedical Limited (**Company**) is pleased to present to Eligible Shareholders the opportunity to increase their investment in the Company through an offer of fully paid ordinary shares under this Share Purchase Plan (**SPP**).

As announced on 4 March 2021, the Company has successfully raised approximately \$40 million from an unconditional placement of shares to professional, institutional and sophisticated investors (**Placement**).

The funds raised under the Placement and SPP will be used by the Company to, amongst other things, finance the Company's contribution to the development and commercialisation of XVD Scanners under the Australian Lung Health Initiative joint venture MRFF Frontiers project, and provide balance sheet flexibility to pursue identified growth opportunities. Further details in relation to the Company's proposed use of the funds are contained in the Company's Investor Presentation and announcement released to ASX on 4 March 2021.

The SPP is conducted in accordance with ASX Listing Rules 7.2 (exception 5) and 10.12 (exception 4), and as such, does not require shareholder approval.

The Offer

The SPP is offered exclusively to all shareholders who were recorded on the Company's share register at 7:00pm (AEDT) on 3 March 2021 with an address on the share register in Australia or New Zealand (each an **Eligible Shareholder**).

The SPP provides Eligible Shareholders with an opportunity to buy a parcel of shares in the Company with no brokerage or transaction costs, irrespective of their existing shareholdings, up to a maximum of \$30,000.

The offer price is \$1.55 per share (**Offer Price**), which is the same as the issue price under the Placement.

The minimum application amount is \$2,500 and the maximum application amount is \$30,000. The Offer Price represents a:

- 15.47% discount to the Volume Weighted Average Price of \$1.83 during the 10 trading day period leading up to the Announcement Date; and
- 10.40% discount to close at 25 February 2021 (being the last trading day before details of the SPP were announced) of \$1.73.

If the total value of applications received under the SPP is greater than \$3 million, the Company will scale back the number of New Shares that will be allotted under the SPP and you may be allocated fewer New Shares than the number for which you applied. In such a case, you will receive a proportionate refund of your application monies.



Frequently asked questions

What is the Share Purchase Plan?

The Share Purchase Plan (or **SPP**) provides Eligible Shareholders with an opportunity to purchase additional fully paid ordinary shares in the Company (**New Shares**) at the same price offered to institutional investors under the Company's recent placement, without brokerage or transaction costs.

All New Shares issued under the SPP will rank equally with existing ordinary shares in the Company (**4DX Shares**), including with respect to voting rights and other entitlements.

Am I an Eligible Shareholder?

You are an Eligible Shareholder if, at 7:00pm (AEDT) on 3 March 2021 (**Record Date**), you were registered as a holder of 4DX Shares with an address on the share register in Australia or New Zealand.

What is the Offer Price of the New Shares?

The offer price is \$1.55 per New Share (**Offer Price**). The Offer Price represents a:

- 15.47% discount to the Volume Weighted Average Price of \$1.83 during the 5 trading day period leading up to the Announcement Date; and
- 10.40% discount to close at 3 March 2021 (being the last trading day before details of the SPP were announced) of \$1.73.

The market price of the Company's shares may rise or fall between the date of this offer and the date on which the New Shares are allotted under the SPP.

If the Company receives an amount that does not equal one of the amounts specified above, the Company may either:

- (a) reject the Application and refund in full the Application money (without interest) to the Eligible Shareholder; or
- (b) apply the dollar amount of the payment to the highest designated parcel that is less than the amount of the payment and refund the excess Application money (without interest) to the Eligible Shareholder.

Terms and conditions

Purpose

The purpose of the Share Purchase Plan (**SPP**) is to offer existing shareholders of 4DMedical Limited ACN 161 684 831 (**Company**) the opportunity to acquire additional fully paid ordinary shares in the Company (**New Shares**) up to a maximum value of \$30,000 at the same price offered to institutional investors under the Company's recent placement, without the need to pay brokerage or transaction costs and without the need for the Company to issue a prospectus.

This document sets out the terms and conditions of the offer under the SPP.

Shareholder eligibility to participate

Participation in the SPP is only open to each person registered as a holder of ordinary shares in the Company (**4DX Shares**) at 7:00pm (AEDT) on 3 March 2021 (**Record Date**), who has an address on the share register in Australia or New Zealand (each an **Eligible Shareholder**).

Due to foreign security laws, it is not practical for shareholders who are resident in countries other than Australia and New Zealand to participate in the SPP.

Participation in the SPP is optional and is subject to these terms and conditions. Offers made under the SPP are non-renounceable meaning that Eligible Shareholders may not transfer their rights to New Shares offered under the SPP.

Joint shareholders are taken to be a single registered holding for the purpose of the SPP, and the joint holders are entitled to participate in the SPP in respect of that single holding only. If the same joint holders receive more than one offer under the SPP, those joint holders may only apply for an aggregate maximum parcel of shares (i.e. \$30,000) between any joint or individual holdings.

If an Eligible Shareholder is a "Custodian" (as defined in ASIC's (Share and Interest Purchase Plans) Instrument 2019/547 (Australia) (**Custodian**) and is the registered holder of shares on behalf of one or more persons who have a registered address in either Australia or New Zealand and who is not in the United States and is not acting for the account or benefit of a person in the United States (each an **Eligible Beneficiary**), the offer is made to that Eligible Shareholder and it has the discretion whether to extend the offer to the Eligible Beneficiaries. To request a Custodian Certificate or further information about the Custodian application process, a Custodian should contact the Company's share registry. Applications received from Custodians must be accompanied by a duly completed and signed Custodian Certificate. Applications that are not accompanied by a duly completed Custodian Certificate will be rejected.

If an Eligible Shareholder holds 4DX Shares as a trustee or nominee for another person, but is not a Custodian, that Eligible Shareholder cannot participate for the beneficiaries of that trust in the manner described above. In this case, the rules for multiple single holders apply.

By electing to participate in the SPP, an Eligible Shareholder is deemed to have certified that the aggregated maximum amount subscribed for under the SPP does not exceed \$30,000. Furthermore, Eligible Shareholders

are deemed to have confirmed, in relation to all New Shares applied for by them under the SPP, that they do not make an application for any other person in circumstances which might involve any breach of securities law of any jurisdiction other than Australia and New Zealand and have agreed to be bound by the Company's constitution in respect of all the New Shares issued to them under the SPP.

Issue Price

Application and notices
