NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

On 24 March 2021, the Company completed the issue and allotment of 22,930,787 fully paid ordinary shares (**Placement Shares**) at \$0.065 per share to institutional and sophisticated investors in connection with the equity capital raising announced on 19 March 2021. The Placement Shares were issued under ASX Listing Rule 7.1.
