



## **Appendix 2A Replacement**

**16 April 2021:** Environmental Clean Technologies Limited (ASX: ECT) (ECT or Company) provides the following replacement to the Appendix 2A, released on 15 April 2021.

This replacement includes details of the 483,592,166 shares (ECT) and 520,000,000 options (ECTOE) issued per the Appendix 3B released on 4 March 2021.
