Change of Year End

As announced at FY20 results on 19 August 2020, Webjet is moving to a 31 March year end commencing 2021. The results to be presented on 19 May 2021 will be for the 9 months ending 31 March 2021.

In the appendix to the Managing Director's presentation given at the AGM on 22 October 2021, Webjet included a pro-forma historical P&L by half for the 12 months to 31 March 2019 and 31 March 2020. For completeness, at its FY21 results Webjet will also be providing a 12 month P&L by half for the 12 months to 31 March 2021.

One of the key commercial drivers stated for the change in year end was the growing significance of WebBeds to the group's earnings, which are skewed to the Northern Hemisphere summer period. The table below sets out seasonality across the group divisions TTV and EBITDA pre-COVID-19.
