- \$1,950K Loan is held by Moneytech and secured against the Company's Ballarat site. The 24-month facility is repayable by monthly instalments. Interest is calculated at 14% per annum. The loan is fully drawn down.
- \$1,000K Trade Finance Facility with Moneytech. Interest is calculated at 7.89% per annum with 120-day terms on each transaction. \$855K was drawn down against this facility on 31 March 2021.
- \$2,000K Debtor Finance Facility is approved by Moneytech with 90% of approved invoice value available for funding. Interest is calculated at 7.49% per annum. No funds have been drawn down on this facility at 31 March 2021. On 31 March 2021, the group had approximately \$200K of approved invoices providing potential borrowings up to \$180K under this facility.

The remainder of the loan facilities are held with the National Australia Bank. This is secured over the assets of the Mildura Pub and Brewery. Interest is payable at 5% per annum.
