- There are no participating rights or entitlements inherent in the Options and the Option holder will not be entitled to participate in new issues of capital offered to Shareholders during the currency of the Options. However, subject to the Listing Rules and Operating Rules of ASX, the Company will ensure that for the purposes of determining entitlements to any such issue, the record date will be at least two (2) Business Days after the issue is announced.
