## Annual General Meeting to be held virtually due to COVID-19 restrictions

Due to new coronavirus restrictions announced by the Victorian Government today it has been decided that the Palla Pharma Annual General Meeting ("the Meeting") to be held tomorrow, 26 May 2021 at 3.00pm (Melbourne time) will proceed as a virtual meeting only. There will be no physical meeting as previously advised in the Notice of Meeting distributed to shareholders and announced to ASX.

Shareholders will be able to participate, ask questions and cast direct votes at the appropriate times whilst the meeting is in progress.

Shareholders can join the meeting by following the instructions set out below.

Enter <a href="https://agmlive.link/PALAGM21">https://agmlive.link/PALAGM21</a> into a web browser on your computer or online device – note, Shareholders will need their Shareholder Reference Number (SRN) or Holder Identification Number (HIN) printed at the top of the Proxy Form.

The online platform will allow you to listen to the proceedings, view the presentations and ask questions of the Board and vote in real-time.

An accompanying presentation will be made available via the ASX announcement platform.

Shareholders will also be given a reasonable opportunity to ask questions related to the business of the meeting, the Company's operations or of the auditor at the end of the meeting. If you would like to ask a question, please register as a shareholder or proxyholder and provide your valid HIN or SRN number when registering. Alternatively, you can register as a visitor, however you will not be permitted to ask questions. Please refer to the Virtual Meeting Online Guide for more information.

All resolutions to be considered at the Meeting will be decided by poll based on proxy votes received prior to the commencement of the Meeting and votes cast at the meeting and via the online platform during the Meeting.

# How to ask a question

Note: Only securityholders are eligible to ask questions.

You will be prompted to enter your securityholder number or proxy details before you can ask a question. To ask a question, click on the 'Ask a Question' button either at the top or bottom of the webpage.

The 'Ask a Question' box will then pop up with two sections for completion.



In the 'Regarding' section click on the drop down arrow and select the category/resolution for your question.

Click in the 'Question' section and type your question and click on 'Submit'.

A 'View Questions' box will appear where you can view your questions at any point. Only you can see the questions you have asked.

If your question has been answered and you would like to exercise your right of reply, you can submit another question.

Note that not all questions are guaranteed to be answered during the Meeting, but we will do our best to address your concerns.
