Extension of Closing Date of Offers

HIGHLIGHTS:

- Entitlement Offer (and all other Offers) closing date extended to 21 June 2021
- Wellnex Life to trade under the code WNX

Wellnex Life Limited (formerly Wattle Health Australia Limited) (ASX: **WHA**) (the **Company**) advises that it has extended the Closing Date of its non-renounceable entitlement offer to Monday, **21 June 2021**.

On 13 May 2021, the Company launched a 1 for 12 pro-rata non-renounceable entitlement offer to Eligible Shareholders at an issue price of \$0.15 per Entitlement Share, to raise up to \$2.88 million (before costs) (**Entitlement Offer**), along with other offers made and as described in the prospectus dated 13 May 2021 (**Offers**).

Since the launch of the Entitlement Offer the Company has received substantial interest from existing shareholders with over 400 applications being received by the Company as at 1 June 2021.

The Board has determined to extend the Closing Date of the Offers, to provide additional time for all Eligible Applicants to participate in the Offers, particularly in light of delays caused by COVID-19 restrictions).

Wellnex is expected to recommence trading on the ASX (subject to compliance with ASX listing rules) with:

- An existing portfolio of consumer brands already in stores and on shelves
- A pipeline of new brands that are ready-to-ship
- \$20+ million in annualised revenue
- Established distribution relationships with leading retail groups, including two 10-year agreements with Chemist Warehouse
- A strong balance sheet from which to accelerated growth.

The funds raised under the Entitlement Offer will be applied towards the costs of the Offers, and the Company's general working capital and growth purposes.
