AUSTRALIAN RESORTS OPERATING CONDITIONS - UPDATE

MELBOURNE: Crown Resorts Limited (ASX: CWN) (Crown) announced today the following update on the current operating conditions at each of Crown's Australian resort properties.

Crown Perth

Following the statement issued by the Western Australian Government on 27 June 2021, new restrictions were imposed across the Perth and Peel regions for a minimum of three days. As a result, Crown Perth has ceased all gaming activities with effect from 12 noon (WST) on 27 June 2021.

Hotel, food & beverage (other than on the casino floor), banqueting and conference facilities will continue to operate in accordance with the temporary restrictions imposed by the Western Australian Government.

Crown Perth will pay employees' rostered hours and salaries (as applicable) over the three-day period.

Crown Melbourne

As announced by the Victorian Government on 23 June 2021, COVID-19 restrictions in metropolitan Melbourne have eased. From 25 June 2021, restrictions on Crown Melbourne's gaming operations include:

- a limit of 300 guests per indoor space, subject to a density quotient of one person per four square metres;
- electronic gaming machines must be spaced 1.5 metres apart, whether this is achieved by every second gaming machine being unavailable for play or physical spacing between gaming machines; and
- table games must operate at 1.5 metres apart, with seated service only.

Crown Melbourne's hotels, restaurants and bars are open and continue to operate in accordance with Victorian Government directions.

Crown Sydney

On 25 June 2021, the New South Wales Government announced stay-at-home orders impacting four designated Local Government Areas, which included Sydney. From midnight on 25 June 2021, food & beverage and conferencing facilities closed at Crown Sydney, whilst hotel services continue to be provided at a reduced capacity. Crown Sydney committed to pay employees' rostered hours and salaries (as applicable) through to midnight on 2 July 2021.

On 26 June 2021, the New South Wales Government extended the stay-at-home orders across Greater Sydney until 9 July 2021. As a result, Crown Sydney's food & beverage and conferencing facilities will remain closed until 9 July 2021 and Crown Sydney's hotel services will continue to operate in a reduced capacity during this time.

Crown Sydney is currently assessing discretionary payments to impacted employees for the period from 3 to 9 July 2021.

Crown will continue to work closely with all State governments and health authorities and will respond to measures taken in relation to COVID-19.
