QUARTERLY ACTIVITIES REPORT

Q Technology Group Limited ("QTG") has released its quarterly cash flow report for the quarter ended 30 June 2021.

As advised to the market on 22 July 2021, the company issued 550,000 Convertible Notes each with a face value of \$1.00 to individual sophisticated and professional investors on 19 July 2021. The Convertible Notes are subject to shareholder approval before they can be converted.

\$550,000 was received by the company on 19 July 2021 and has been used to pay out all overdue creditors of the company in accordance with Creditor and Loan Deeds of Settlement. The remaining proceeds will be used for ongoing compliance and working capital costs.

The creditor and loan settlements paid in accordance with executed Deeds of Release were at amounts significantly less than recorded in the liabilities of Q Technology Group at 30 June 2021 and will result in a gain of approximately \$1,200,000 for the year ended 30 June 2022.

On 21 July 2021 the existing directors of QTG resigned and the board was pleased to announce the appointments of Peter Chai, Susan Lay and Sesidhar Kolikonda to the board of Q Technology Group.

The new board members are in the process of identifying new opportunities for the Company and will provide a market update in accordance with ASX Listing Rules when completed.

	Answer: Yes. The Company was financed by shareholder loans during the quarter and year ended 30 June 2021. On 19 July 2021 the company received \$550,000 from the issue of convertible notes. The funds were partly used to pay out existing creditors and the remaining balance will be used for ongoing compliance and working capital costs.

Answer: Yes, the Company received \$550,000 funding from issuing convertible notes on 19 July 2021. The new directors intend to identify future opportunities which once identified will be announced in accordance with ASX Listing rules.
