



Unaudited Half-Year Accounts and ASIC Relief Notification

Fluence Corporation Limited (ASX: FLC) ("Fluence" or the "Company") advises that it is relying on the relief granted by ASIC in *ASIC Corporations (Extended Reporting and Lodgement Deadlines – Listed Entities) Instrument 2020/451* dated 15 May 2020, as extended by *ASIC Corporations (Amendment) Instrument 2021/315* ("ASIC Relief") to extend the lodgement date for its audited half year accounts required to be lodged with ASIC under section 320 of the *Corporations Act 2021 (Cth)*.

The Company advises that it take advantage of the COVID-19 extension in relation to the filing of its reviewed half-year accounts. The auditors had advise that while their review procedures have been largely finalized, due to unforeseen challenges presented by COVID-19 conditions, certain internal documentation and quality assurance procedures remain to be completed before the reviewed half year financial statements can be released to the ASX. The Company's unreviewed half year accounts for 30 June 2021 are enclosed within this ASX Announcement.

In accordance with the ASIC Relief and the ASX's class waiver '*Extended Reporting and Lodgement Deadlines*' under Listing Rule 18.1, the Company's half-year accounts will be lodged on the earlier of the date of finalisation and 14 October 2021 (being 106 days after the end of the half-year) and a further announcement to the market will be immediately made if the Company becomes aware that there will be a material difference between its unreviewed half-year accounts and its reviewed half-year accounts.
