PSC INSURANCE GROUP LTD (PSI) – ISSUE OF 364,230 FULLY PAID ORDINARY SHARES - NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

This notice is given by PSC Insurance Group Limited ACN 147 812 164 (**PSI**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

On 9 July 2019, PSI announced its entry into an agreement to acquire the business of Griffiths Goodall Insurance Brokers Pty Ltd with a portion of the consideration to be in the form of fully paid ordinary shares in PSI (**Shares**) to be issued through its placement capacity under ASX Listing Rule 7.1.

As announced on 26 July 2019, PSI completed the acquisition and issued 3,944,287 Shares under tranche 1 of the consideration with all but 394,428 of those Shares being subject to a 24 month voluntary escrow to 26/07/2021.

On 31 August 2020 a further 506,227 Shares were issued as part consideration on the 1st Anniversary Rise and Fall Amount payment with 455,605 subject to a voluntary escrow to 26/07/2021, as per BSA, and the balance of 50,622 Shares not subject to escrow.

On 16 July 2021 PSI lodged notice with the ASX that all Shares noted above as being in voluntary escrow were to be released from escrow on 27 July 2021.

This notice relates to a further 364,230 Shares issued 31 August 2021 as part consideration on the 2nd Anniversary Rise and Fall Amount payment and relates to all Shares issued as consideration with no shares in this issue subject to voluntary escrow per the BSA. This issue completes all rise and fall amounts in relation to the acquisition of the business of Griffiths Goodall Insurance Brokers Pty Ltd.

PSI confirms:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is being given under section 708A(5)(e) of the Corporations Act;
- (c) as at the date of this notice, PSI has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to PSI; and
 - (ii) section 674 of the Corporations Act; and
- (d) as at the date of this notice, there is no 'excluded information' of the type referred to in section 708A(7) and section 708A(8) of the Corporations Act.
