
SKS Technologies Group Limited (ASX:SKS) is focused on building a leading integrated technology solutions business with nationwide operations.

## **Investment Highlights**





**Aggressive organic growth strategy increasing capability and scale of SKS Technologies' existing operations** with 34% annual sales growth, 195% growth 2H21 compared to 2H20. Order book grown by 266% year on year to \$26m.



Strategic acquisitions after divesting non-core business' set strong foundations for growth.

Achieved an annualised revenue run rate in excess of \$60M.



### Driving higher margins under a recurring revenue model

Recently announced the acquisition of Integrated Solutions Group Queensland bringing with it 61% of recurring revenue. Further geographic expansion as acquisitions bolster presence across Australia.

## **Financial Summary - Continuing Operations**




Year-on-year growth in both sales and work on hand, with sales growing by 34% and work on hand growing by 266% from FY20 to \$26M.


Following the strategic divestment of non-core business lines, SKS Technologies has seen a strong profit in FY21 having generated a net profit after tax (NPAT) of \$1.74M, an increase of \$2.95M from the previous financial year.

Cash flow positive from continuing operations of \$2.59M, representing a \$1.50M increase.

SKS Technologies has access to a **\$3 million working capital facility** to fund a record order book.

**Group** earnings per share increased by 3.4 cents.






## **Growth Strategy**



SKS Technologies continues to expand its product offering and progress its technology growth strategy by expediting a roadmap in the Australian market.

SKS Technologies is currently executing on the third cornerstone of our growth strategy, Technology Expansion, through the acquisition of Information Technology provider Integrated Solutions Group Queensland, having already consolidated and restructured the business with a focus on core growth business strategies as the previous pillars of growth.

### Integrated Solutions Group Queensland Pty Ltd Overview

SKS Technologies recently acquired specialist IT provider Integrated Solutions Group Queensland Pty Ltd for total consideration of \$5m.

This acquisition fits into the third cornerstone of SKS Technologies' strategy, Technology Expansion, which aims to drive higher margins with a recurring revenue model by leveraging the convergence of IT and Audio-Visual networks, to make the natural progression towards a complete integration.

Integrated solutions are a customer-focused, Brisbane based team who are passionate about providing tailored and expert IT support services for complex businesses.

Strategic acquisition directed at **specialised IT operations**, services including data centres, voice & video, security & advanced networking, onsite infrastructure & project management.

The **convergence of AV/IT has been heightened** due to Covid and it is more important than ever to make sure meeting places are a more engaging experience for people returning to the workplace.


Expanding customer base - Integrated Solutions brings 32 employees based in its Brisbane office. Integrated Solutions will continue operations in Brisbane to **build a greater presence** in QLD and **enable a greater sales effort** across SKS Technologies' national footprint.

Integrated Solutions brings ~\$6m revenue per annum with additional \$0.5m working capital, with ~61% of its revenue from recurring income driving higher profit margins.
