Industria Company No.1 Limited (ACN 010 794 957) ("Company") and APN Funds Management Limited (ACN 080 674 479) ("Responsible Entity") in its capacity as responsible entity of Industria Trust No. 1 (ARSN 125 862 875), Industria Trust No. 2 (ARSN 125 862 491), Industria Trust No. 3 (ARSN 166 150 938) and Industria Trust No. 4 (ARSN 166 163 186) (Trusts) (the Company and APN FM together the Issuers and the Company and the Trusts together "APN Industria REIT" or "ADI") (ASX Code: ADI) requests an immediate halt in trading of ADI's securities to apply from the commencement of trading on 23 September 2021 pursuant to ASX Listing Rule 17.1.

- ADI is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
