

# **Growing Pipeline**

Pipeline continues to develop with several sizable opportunities now entering the contract negotiation stage which has provided a heightened optimism about the broader opportunity for Alcidion, particularly in the UK market.

Increasingly seeing the potential to cross/up sell our products to existing customers.



- As end of Q1, \$17.2M of contracted revenue to be recognised in FY22, 17% increase on pcp
- Further \$2.2M of scheduled renewal revenue which is expected to be converted to contracted revenue over FY22
- Post end of Q1, signed a further \$3.1M of contracted revenue (Approx. \$0.9M will be recognised in FY22)

# Operational Highlights – Q1 + YTD (Oct)

## Sydney LHD

- New contract with TCV of \$1.8M over 3 years, won via competitive tender process
- Use of Miya Precision in supporting virtual care of acute diverticulitis patients (likely to include other patients) via rpavirtual along with roll-out of Alcidion's new patient care app, Miya Care
- Key reference site highlighting functionality of Miya Precision in supporting virtual care monitoring across hospitals in Aust.

## Queens Hospital Burton NHS (ExtraMed)

- First new ExtraMed contract win (TCV \$0.6M over 3 years) following the acquisition of ExtraMed in April 2021
- Part of University Hospitals of Derby and Burton NHS Foundation Trust, one of the largest NHS trusts in the UK
- Cross-sell validation as Burton is a current user of Patientrack

# Derby Teaching Hospitals (ExtraMed)

- Contract extension (TCV \$0.6M over 3 years) with Derby Teaching Hospitals for use of ExtraMed platform (IPFM)
- Derby is a 'sister Trust' to Queen's Hospital Burton and have documented success in reducing length of stay using the ExtraMed solution extension of their licence and support contract validates the solutions positive impact on patient care

#### **Board Updates**

- Appointed Victoria Weekes and Daniel Sharp to the Board as Independent NEDs
- Highlight's ability to attract high calibre Directors and part of continued evaluation of skills on the Board to support next phase of growth
