

Company Update

Australian internet of things (IoT) and healthcare technology company, Oakridge International Limited (ASX: OAK) (“Oakridge” or the “Company”) is pleased to provide the following business update alongside its Appendix 4C Quarterly Cash Flow Report for the quarter ended 30 September 2021 (the “Period”).

During the quarter the Company continued on its path to focus on an increase in sales activities, the delivery of customer projects and an increase in product development to further enhance our existing product offering.

Recent interstate lockdowns and closures, as a result of the Covid pandemic, have had an impact on revenues for the Period.

Related party payments of \$36,332 relate to Director and Executive Officer fees.

Healthcare Business

JCT Healthcare (“JCT”), a wholly owned subsidiary of the Company, is a provider of innovative technology solutions for the healthcare sector. JCT develops and distributes its own range of nurse call hardware and software solutions for use across multiple healthcare sectors including hospitals, aged care, disability care and supported independent living.

JCT continues to focus on an increase in business development activities. COVID Border closures and lockdowns have restricted travel and had a negative impact on quarterly revenues and new projects being secured.

JCT continues its product development efforts to ensure it meets its growing customers’ needs. Our focus on the Remote Tracking Location System (RTL), GPRS System and the Smart Technology Pack will bolster the JCT solution suite and provide additional revenue streams. Completion of the RTL Tracking system and GPS tracking system remains on track for completion towards the end of this calendar year.

JCT increased its online presence to greater promote current, and emerging products and services. Consistent and engaging posts are regularly updated on all the major social platforms to support JCT’s overall strategy.

Legacy Issues

There has been no change since the last quarter. The final step in the remediation process for the Penola geothermal well is due to be completed in the coming quarters. Once completed, a \$100,000 security bond will be returned to the Company.

Others

As announced on 2 January 2020, the Company completed a A\$250,000 share placement (“Placement Agreement”) with Teko International Limited (Teko). On 28 July 2020, the Company held a discussion with Teko in respect to a potential claim asserted by Teko against the Company for allegedly misrepresenting the Company’s unrecorded liabilities, including the Heuresy liability payment previously disclosed, by its then directors. The Board believes that there may be some exposure to the Company in respect to the representations made by the then Board members. If the Company were to be subject to legal action that could be taken by Teko, there could be no assurance as to the outcome or the costs required to defend any such action. The Company will continue to discuss the issue with our legal advisors and negotiate with Teko to seek the most desirable outcome for the Company and its shareholders.
