Q Technology Group Limited ("QTG") has released its quarterly cash flow report for the quarter ended 30 September 2021. The company recorded a net cash increase of \$158,000 for the quarter.

As previously advised to the market the company issued 550,000 Convertible Notes each with a face value of \$1.00 to individual sophisticated and professional investors on 19 July 2021.

The proceeds received were used to pay out all overdue creditors and existing loan accounts of the Company with the remaining proceeds being used for ongoing compliance and working capital costs.

The board is in the process of identifying new opportunities for the Company and will provide a market update in accordance with ASX Listing Rules when completed.
