## IMPLEMENTATION OF SCHEME OF ARRANGEMENT

rhipe Limited ('**rhipe**' or the '**Company**') is pleased to announce that the scheme of arrangement under which Crayon Software Experts Australia Pty Ltd, an indirectly wholly-owned subsidiary of Crayon Group Holding ASA ('**Crayon**'), will acquire all of the issued shares in rhipe (the '**Scheme**'), has been implemented today.

Accordingly:

- Crayon Software Experts Australia Pty Ltd now holds all of the shares on issue in rhipe;
- the fully franked special dividend of \$0.13 for each rhipe share was paid on Monday, 25 October 2021 to each rhipe shareholder who held rhipe shares as at 7:00pm (Sydney time) on Monday, 18 October 2021; and
- the Scheme consideration of \$2.37 cash for each rhipe share has today been paid to each rhipe shareholder who held rhipe shares as at 7:00pm (Sydney time) on Wednesday, 27 October 2021.<sup>1</sup>

### Changes to rhipe's board of directors

With effect from the implementation of the Scheme, Gary Cox, Dominic O'Hanlon, Dawn Edmonds, Mark Pierce, Michael Tierney, Inese Kingsmill and Olivier Dispas have resigned as directors of rhipe.

Melissa Mulholland, Jon Birger Syvertsen and Mark McLellan have been appointed as new directors of rhipe.

### Delisting of rhipe from ASX

As previously announced, trading in rhipe shares on the ASX was suspended from the close of trading on Thursday, 14 October 2021. rhipe has applied to the ASX to have quotation of its shares terminated and for rhipe to be removed from the official list of the ASX, with effect from close of trading on Thursday, 4 November 2021.
