## JobKeeper Payments Notification

This information accompanies the JobKeeper payments disclosure notice lodged by Tabcorp Holdings Limited (**Tabcorp**) in respect of the 2020 (**FY20**) and 2021 (**FY21**) financial years, and is supplied in accordance with subsection 323DB(1) of the Corporations Act 2001.

Tabcorp was eligible for JobKeeper in relation to its Gaming Services business and accessed \$12.1 million in payments over the two financial years (FY20 and FY21).

These JobKeeper payments were used as intended and passed on to more than 500 stood down employees across Australia in roles related to the Gaming Services business.

Tabcorp's Gaming Services business was substantially impacted by COVID-19. It recorded EBIT losses in both FY20 and FY21 and incurred impairments totalling \$307 million.

Tabcorp has taken substantial measures to support its employees and hotel and club venue partners during the pandemic.

These included waiving more than \$200 million in contracted fees to venues when their trade was impacted by COVID-19. The majority of these waived fees relates to Gaming Services.

Tabcorp also continued to pay – rather than stand down – more than 150 employees when there was reduced workload during the most recent NSW and Victorian trading restrictions in FY22.
