**Jobkeeper Payments Notification**

Johns Lyng Group Limited (ASX:JLG) provides the attached notice in accordance with section 323BD(1) of the *Corporations Act (Cth) 2001*.

Jobkeeper payments were received in respect of two recently acquired subsidiaries (Air Control and Advantage Styling) with large minority equity interests and discrete payrolls. Both Air Control (60% equity interest) and Advantage Styling (65% equity interest) were significantly negatively impacted by COVID-19. The Jobkeeper payments detailed in the attached notice prevented staff stand-downs and retrenchment during the period.
