# Domain sale and advertising agreement with Bitbuy

Kogan.com Limited (the Company; Kogan.com; Kogan; ASX: KGN) and Bitbuy, one of Canada's largest crypto trading platforms, have entered into agreements whereby the parent company of Bitbuy will acquire the domain name bitbuy.com from Kogan. In addition, Kogan and Bitbuy have also entered into an advertising arrangement whereby Kogan.com will provide marketing support to Bitbuy's future launch into the Australian market.

Kogan owns and manages a portfolio of domain names, and is pleased to announce that it has sold the domain name bitbuy.com to First Ledger Corp, an Ontario, Canada Corporation ("**First Ledger**"), the parent company of Bitbuy Technologies Inc. ("**Bitbuy**"). Bitbuy is one of Canada's most secure and trusted platforms for Crypto trading, recently becoming the first approved marketplace and dealer as granted by their local security regulators.

In announcing the agreements, Kogan.com Executive Director David Shafer, said:

"The domain sale not only delivers returns for Kogan shareholders but also provides an opportunity to benefit from Bitbuy's future success in the crypto business abroad and potentially in the Australian market."

Commenting on the agreements, Chief Operating Officer at Bitbuy Jordan Anderson said:

"With a Kogan.com partnership in place, we are confident of a successful expansion of Bitbuy into Australia."

Relevant details of the agreement are as follows:

- Kogan will transfer to First Ledger the domain: bitbuy.com ("Domain")
- Kogan will provide advertising services to Bitbuy in connection with their future launch in Australia
- Upon transfer of the Domain, Kogan will receive:
  - USD\$1.5m in cash; and

 a warrant entitling Kogan to approximately CAD\$2.8m in either equity in First Ledger or cash upon exercise of the warrant which will occur within one year after the transfer of the Domain.
