## **ASIC action against OnePath Custodians**

Insignia Financial notes ASIC's media release today regarding its action against OnePath Custodians (OPC) relating to disclosure of Adviser Service Fees (also known as Plan Service Fees) in relation to the Integra Super product.

Insignia Financial and OPC are carefully considering ASIC's action. The action relates to issues arising prior to Insignia Financial's acquisition of ANZ's Pension & Investments business (including OPC) in January 2020, and alleges that from December 2015 approximately \$4.3 million in Plan Service Fees were deducted from members' accounts without sufficient disclosure.

Separate to any question of liability, OPC and ANZ are remediating impacted members, with OPC's remediation expected to be completed by the end of this month. Insignia Financial remains committed to ensuring OPC's identified Plan Service Fee issues are appropriately resolved.

Insignia Financial continues to focus on developing and implementing its roadmap of product and platform simplification and we are confident this program will improve member outcomes.
