Remaining IMUOB Options Exercised, Option Underwriting Agreement and Appendix 2A

Imugene Limited (ASX: IMU), a clinical stage immuno-oncology company, advises that it has entered into an underwriting agreement for the remaining ASX- listed IMUOB options.

Baker Young Limited ("Baker Young") has agreed to underwrite the remaining 713,365 IMUOB options. Baker Young will subscribe for the corresponding shares to be issued at the IMUOB option exercise price of \$0.04.

Baker Young will not receive an underwriting fee for the exercise of the IMUOB Options but is entitled to reimbursement of certain expenses. The underwriting agreement includes a number of customary termination events including not limited to circumstances where the S&P/ASX 200 Index closes at a level that is 90% or less of the level of that index as at the close of trading on the business day immediately preceding the date of the underwriting agreement, or a materially adverse change occurs in the assets, liabilities, financial position or operations of the Company.
