Quarterly Activities Report and Appendix 4C – December 2021 Quarter

SUMMARY

- Positive quarterly cash flows of \$2.1m generated from underlying operating activities for the December 2021 quarter (Q2 FY22) compared to negative cash flows of \$4.6m from underlying operating activities for the previous quarter (Q1 FY22).*

- \$13.2m of unused facilities available as at 31 December 2021. Cash on hand as at 31 December 2021 was \$1.4m resulting in total available funding \$14.6m.

Quarterly Activities

There were no material changes in the principal activities within the Company's Cleaning and Security segments during the quarter ended 31 December 2021. The Company announced on 7 December 2021 the investment of 1.1m into a 49% non-controlling share of indigenous owned Codee Cleaning Services in WA. Codee's operating cashflows are not incorporated into this report.

The Group's underlying revenue of \$66.2 million for the 3 months ending 31 December 2021 was in line with revenue of \$65.6m in the September 2021 quarter.

Contract revenue of \$54.8m in Q2 FY22 declined by \$1.1m or 2.0% compared to contract revenue of \$55.9m in Q1 FY22. The decline in contract revenue was mostly due to:

- the dis-continuation of the QIC Ltd contract in the September 2021 month, offset by
- a reduction in COVID-19 restrictions in NSW, Victoria and New Zealand in Q2 FY22 compared to extended COVID-19 lockdown periods in Q1 FY22.

Pleasingly, the contract revenue reduction was more than offset by an increase of \$1.7m in the more profitable ad hoc revenue.

Payments to related parties, and their associates for the quarter ended 31 December 2021 totalled \$496,357, comprising:

- Wages and other benefits of \$105,392 paid to Mr Royce Galea, a substantial shareholder of the Company, in his capacity as an Executive Director;
- Wages and other benefits of \$80,392 paid to Mr Stephen Lidbury, a substantial shareholder of the Company, in his capacity of General Manager of Security. Office rent of \$12,634 was paid in the current quarter on normal commercial terms to an entity related to Mr Stephen Lidbury;
- Consulting fees of \$93,000 were paid to Wayne and Eileen Crewes Pty Ltd, a substantial shareholder of the Company;
- Wages and other benefits of \$33,000 were paid to a close family member of the controller of Wayne and Eileen Crewes Pty Ltd, in the associate's capacity as an employee of the Group;
- Consulting fees of \$171,939 were paid to Jungle Capital Pty Ltd, an entity that Mr Stuart Grimshaw, the Company's Chairman, has a minority interest in, for corporate and strategic advisory services.

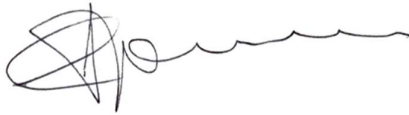
