Second quarter update and cashflow

Highlights:

- 272k in cash receipts for the quarter
- 74% decrease in expenditure on previous quarter
- \$1.204m in cash held at end of quarter

28 January 2022 – IoT solutions company, Constellations Technologies Limited (ASX: CT1) (the "Company" or "Group") is pleased to provide a summary update on its activities for the quarter ended 31 December 2021.

Sales

Cash receipts from customers continue to be received inline with existing contracts and milestone obligations. Cash receipts for the quarter were \$252k,which was \$18k above the previous quarter and primarily due to organic growth in the Groups' existing Australian customer base.

Management continue to persue its strong Australian sales pipeline which is slowly recovering from the prolonged COVID-19 lockdowns across Australia in 2021.

The Company is continuing to undertake trials in a variety of industries across Australia, however, as at the date of this update, no material contracts have been signed.

The Group's China sales pipeline is experiencing a prolonged impact from COVID-19, with no new material sales contracts being signed for the first half of FY22. China Management continue to deliver on its existing sales contracts in line with its milestone obligations.

Expenditure & financing activities

During the quarter, the Company continued with its cost reduction initiatives put in place in previous quarters, with a primary focus on reducing staff and research & development expenditure. As a result of these activities the net operational burn for the quarter decreased by 74% on the previous quarter to \$293k for the quarter.

Related party cash payments for the quarter were \$65k and consist of salary related payments for CEO, Kartheek Munigoti; director's fees to the Company's two non-executive directors and office rental and legal fees paid to entities associated with the Chairman.

The board thanks all shareholders for their continued support and interest in the Company.
